courses and research. Innovations in modern teaching learning process are implemented avoiding rigidity and exclusion in extending the borders of learning and research resources.



all teaching and non-teaching positions are some of the top priorities at present.




INTERNATIONAL AFFAIRS (OIA)

In order to meet the global standards and expectations of the international student admissions and collaborations, the University has established a dedicated cell 'Office for International Affairs' (OIA) with Director (Prof. Vincent Mathew) and Joint Director (Dr. Ravi Kumar Kanaparthi). The OIA acts as a single point of contact for all foreign student admissions and other international academic and research collaborations. The OIA coordinates the University's foreign student admissions and international collaborations in close contact with the university leadership, various faculties and departments. Besides, the office is responsible for the University's bilateral agreements and participation in networks and organizations. Overall, OIA is committed to strengthen international collaborations especially foreign student admissions, student and faculty exchange programmes and starting dual and twinning degrees in collaboration with foreign universities.

The university has setup a high level advisory committee under the chairmanship of Hon'ble Vice-chancellor to mentor the OIA.

FOREIGN STUDENTS ADMISSION

A prospective student, seeking admission in the Central University of Kerala can submit application in two different ways.

- 1. Application can be submitted directly in the online portal (self-financing mode)
- Application can be submitted through the Govt. of India sponsoring agencies Indian Council for Cultural Relations (ICCR) http://a2ascholar

General Information and Instructions for the Applicants

1. Who can Apply?

Any Foreign National student can apply for admission. The term "Foreign National" implies any candidate holding a passport of a foreign country. This category includes any Person of Indian Origin (PIO) or, Overseas Citizen of India (OCI) cardholder who has a foreign country's passport. A non-resident Indian (NRI) with Indian Passport is considered as Indian National and therefore such student cannot apply for admission under this mode. Persons of Indian origin, holding non-Indian passports are eligible to apply for admission to the academic programs of CUK, provided they hold an Overseas Citizenship of India as per section 7B(1) of the Indian Citizenship Act, 1955. Additionally, they need to satisfy all the eligibility criteria for admission prescribed for the Indian citizens. Persons of Indian origin, with foreign passports and not holding an Overseas Citizenship of India as per section 7B (1) of the Indian Citizenship Act, 1955 may seek admission through the





2. Number of seats:

A maximum of 10% of the foreign national students shall be admitted over and above the approved intake in a given programme offered by a University Department/Center subjected to the availability of infrastructure. The University reserves the right to increase OR decrease the total foreign students' intake in each programme. Refer page no. X for exact number of seats available in each program and their basic eligibility for admission.

3. Eligibility:

- (A) **Applications:** The University is considering the admission of foreign nationals, "in absentia", on the basis of their desire "to be considered in absentia". All such applications to any programme of the University are subjected to the condition that they are found eligible for admission by the University.
- (B) **Age limit**: At the time of admission, applicants' age must be in between 18-30 years for Under-graduate (UG), Post-graduate (PG) and PG diploma programmes. However, there is no upper age limit for PhD programmes.
- (C) **Equivalence Certificate:** Only those foreign students who have qualified from foreign universities or Boards of Higher Education recognized as equivalent by the 'Association of Indian Universities' (AIU) are eligible for admission (including foreign students studied/studying in recognized Indian Colleges/Universities). In case the University/Board is not





included in the list, the applicant has to obtain and submit an equivalence certificate from AIU along with the application. Submission of the Equivalence Certificate from AIU is mandatory for such foreign national applicants.

- (D) **Academic Qualification**: A prospective foreign national student has to fulfill the basic eligibility conditions, which are the same as the Indian students, except age limit. If the applicant's degree is not matching with any of the programmes offered by the University, the applicant can be considered for an equivalent programme. An interview will be conducted for MSc and PhD programmes, before the final decision. The decision of the University is final in this regard.
- (E) **English proficiency:** Proficiency in English is a pre-condition for admission, especially for the applicants belonging to non-native English speaking countries. Those who have completed qualifying degree from India are exempted from this mandatory requirement. Similarly, those who have studied for at least five years in English (including their qualifying degree) in their country/other countries are also exempted from the English proficiency examination. And those who are seeking this exemption shall provide sufficient



documentary evidence for the same. All other applicants should provide proof of International English Language Testing System (IELTS)/Test of English as Foreign Language (TOEFL)/Indian Scholastic Assessment (Ind-SAT/any other equivalent test performance along with the application. The score should not be older than two years.

4. Last date for Application:

Foreign Nationals can submit applications throughout the academic year in a prescribed format or online portal. However, September 20 is regarded as the last date for processing applications for 2021-2022 academic year. The decision on admission shall be intimated to the applicants before the first/second week of October, 2021. The application can be downloaded from https://www.cukerala.ac.in/CUK Internati onalStudents. Separate application for each programme shall be submitted by an applicant who desires to apply for more than one programme.

5. How to Submit Application?


(A) Online Portal

Eligible foreign students seeking admission in UG/PG/PG Diploma/PhD programmes can submit application through online portal by following the procedure summarized below.

- 1. First time users are required to Register by providing basic details.
- 2. After successful registration, you will be provided login details to the registered email ID.



- 10. Paying Application Fee is Mandatory for Processing Application: Rs. 7500 for UG programmes, Rs. 11000/- for PG & PG Diploma Programmes; Rs. 15000/- for PhD programmes. The fees can be paid through any online payment gateway credit card/debit card/NEFT transfer/wire transfer etc. Proof of the payment shall be attached with the application. This fee is one-time payment for processing the application and it is NON-REFUNDABLE at any circumstances.
- 11. The University is not liable for any of funds transfer failure. The Application fees is exclusive of bank service charges.

12. A separate application must be submitted if the student is eligible for more than one programme along with applicable application fee. In any case, a student can submit maximum of two applications.

(B) OFFLINE

Eligible foreign students seeking admission in UG/PG/PG Diploma/PhD programmes may submit duly filled application (Offline Mode) either in person or by post or scanned soft copy by email. Application can also be submitted through authorized person on behalf of the student (In all such cases, authorization letter format must be attached along with application). The following steps need to be followed while submitting offline applications.

- 2. Take a printout of the application and fill all details and append signature
 - 3. Attach photocopies of all the documents/certificates/letters
 - 4. Necessary Documents (to be attached while

submitting/sending application by post/in person/email):

- i. Passport (all pages including empty pages)
- ii. Copy of National ID card/Unique ID card (if applicable)
- iii. One passport size photograph with white background
- iv. Scanned Signature of the Applicant
- v. Proof of English proficiency (TOFEL/IELTS/DUOLINGO Score etc.)
- vi. Statement of Purpose (not more than two pages)
- vii. Two Recommendation Letters (references must be on letter heads of the recommending Faculties/Teachers)
- viii. Financial Undertaking
- ix. Research proposal ((applicable to PhD programmes))
- x. Experience Certificates (if applicable)
- xi. English Translated Certificates (if originals are in other language)
- xii. No objection Certificate/Migration Certificate of qualifying degree, if it is completed from India.
- xiii. Fellowships awardees must attach 'Fellowship Award Letter' along with the application.
- xiv. Certificates/Marks sheets of the qualifying examinations as stated below:

- 5. Pay the application Fee INR 7500 (UG programmes) or INR 11000 (PG & PG Diploma Programmes) or INR 15000 (PhD programmes) through any online payment gateway credit card/debit card/NEFT transfer/wire transfer etc. Proof of the payment shall be attached with the application. This fee is one-time payment for processing the application and it is NON-REFUNDABLE at any circumstances.
- 6. A separate application must be submitted if the student is eligible

- for more than one programme along with applicable application fee (Two times the actual application fee). In any case, a student can submit maximum of two applications.
- 7. If possible, the Application Form attested by the Indian Diplomatic Representative or a responsible Official of the Ministry of Education of applicant's country or an Official of the applicant's country's Embassy/High Commission in India and the same can be submitted.

6. Important Dates:

In principle, all eligible foreign students can submit applications throughout the academic year for all the programmes. For 2021-22 academic year admissions:

UG/PG/PG Diploma programmes: 20th September 2021 (Late applications would be automatically considered for the next cycle of admissions, ie, 2022-23 academic year only)

The late applications would be considered for next cycle of admissions, ie, December, 2021/January 2022 session only.

7. Selection Procedure:

PhD programmes

- ♦ After initial scrutiny, the OIA will be forwarded applications to the respective Academic Departments.
- ♦ The Academic Departments will verify the academic background of the applicants and basic eligibility for the applied programme.
- ♦ The Academic Departments would conduct the interviews (Online) to all the short-listed candidates and prepares a merit list. (necessary information about will be communicated before conducting interview)
- ♦ Accordingly, the provisional admission letters will be sent to the selected students.
- ♦ If a student denies the provisional admission offer, the opportunity will be given to the next student in the merit list.

Note: Your academic background and interview performance are very important to secure admission in this premiere University. Meeting basic eligibility does not guarantee admission in any programme. Admission is highly competitive. Avoid communicating with Departments or OIA during the scrutiny process. However, we expect you to provide necessary informations as and when required by the OIA/Departments.

8. Provisional Admission Process:

- ♦ A student who receives provisional admission letter need to pay ONE YEAR admission and tuition fees in advance to confirm the seat and to get provisional admission in Central University of Kerala (refer the fee structure). The remaining fees of the programme can be paid semester-wise on arrival to the campus in INDIA. (Refer the fee structure applicable for 2021-2022 academic year on www.cukerala.ac.in)
- ♦ Only after paying the prescribed fee, Provisional Admission will be given by the respective departments.

9. Confirmation of Admission:

Provisional admission of a foreign student will be confirmed only after verifying original certificates on arrival to the University Campus in INDIA. Any discrepancy/mismatch of the submitted certificates/documents with the originals will be treated seriously and accordingly provisional admission offer will be cancelled.

10. Reporting to University:

i. A student selected for admission is required to report to the Director, OIA with the following original documents along with one photocopy of each original document. Certified English translated copies should also be submitted if they are in vernacular languages. certificates and transcripts

ii. All the other submitted alona with the application

- iii. Passport and VISA
- iv. Medical fitness certificate from Medical Officer, Central University of Kerala. Applicable fees for medical tests shall be borne by the student concerned.
- v. Health Insurance policy
- vi. Copy of admission fees payment details

11. Visa & Health Insurance:

(A) Visa: The provisional admission letter offered to a foreign student can be used to obtain appropriate VISA from his/her local Indian embassy/ High Commission.

All UG, PG and PG Diploma students must obtain "Student VISA". All Ph.D. students should obtain a "Research VISA". Prospective applicants for Research VISA need to submit a research proposal along with University's provisional acceptance of affiliation to the Consulate. Any other documents required for getting India VISA will be provided based on request of the provisionally admitted applicants.

The visa must be endorsed in the name of Central University of Kerala. No other endorsement will be acceptable.

No foreign national will be given final admission without a valid student visa/research Visa.

(B) Health Insurance: All the provisionally admitted students are required to buy health insurance policy worth of Rs. 5,00,000/-before arriving to India. It is essential that the student's health insurance policy must be valid throughout the period of the student's stay in this University.

12. Registration with FRRO

Under the Registration of Foreigners Rules 1939, every foreigner who is in India, to stay for ninety (90) days (for purpose of other than tourism) or above is required to register himself/herself within fourteen (14) days of arrival in India with the Foreigners Regional Registration Officer in the place of ordinary residence and declare his/her registered address.

The OIA will assist the students in preparing necessary documents for the purpose.

13. Hostel Accommodation:

Upon request, all the admitted foreign students will be given accommodation either in the existing Men's and Ladies' or University managed hostels. Those who are accommodated in hostels will have to pay Hostel admission fee, rent, mess charges etc.

14. Travelling to India:

Provisionally admitted students with valid VISA and original documents can plan their travel to India and to the University with prior intimation to the OIA. The OIA will arrange a pickup service from the arrival Airport/Railway station for the foreign students those who are arriving for the first time.

15. Discipline and Campus regulations:

All the admitted foreign students will be treated like Indian students enrolled in the same programme. He/she should abide by all the 'Campus Regulations of Students', 'code of conduct', and 'hostel rules and regulations' (refer CUK guidelines in the website www.cukerala.ac.in).

16. Transfers and change of courses:

A foreign student admitted in a particular programme will not be permitted to change the programme. Transfer from Central University of Kerala to another educational institute with in India is also not permitted.

17. Cancellation of Admission:

i. If, a provisionally admitted foreign student desires to cancel his/her admission due to denial of Indian VISA and if the student had already paid admission fees, then the fees paid will be returned upon deducting bank and or University service charges.

- ii. The admission cancellation procedure will be governed by the general admission guidelines of Indian students, which may be amended time to time.
- iii. No reimbursement for cancelation of admission of a foreign student based on discrepancy/mismatch of the submitted certificates/documents with the originals.

18. Government of India Scholarship

Anti-Discrimination cell CUK

Definition of "discrimination":

"Discrimination" means any distinction, exclusion, limitation or preference which has the purpose or effect of nullifying or impairing equality of treatment in education and in particular, of depriving a student or group of students on the basis of caste, creed, religion, language, ethnicity, gender and disability of access to education of any type at any level.

As per the UGC (Promotion of Equity in Higher Educational Institutions) Regulations [3(2) (h)] 2012, an "Anti-Discrimination" Cell in the Central University of Kerala been constituted to:

- i) Safeguard the interests of the students without any prejudice to their caste, creed, religion, language, ethnicity, gender and disability.
- ii) Eliminate discrimination against or harassment of any student in all forms in higher educational institutions by prohibiting it and by providing for preventive and protective measures to facilitate its eradication and punishments for those who indulge in any form of discrimination or harassment.
- iii) Promote equality among students of all sections of the society.
