9. Overhead expenses are meant for the host Institute towards the cost for providing infrastructural facilities and general administrative support etc. including benefits to the staff employed in the project.

10. The organization/institute/university should ensure that the technical support/financial assistance provided to them by the Science & Engineering Research Board, a statutory body of the Department of Sciences & Technology (DST), Govt. of India should invariably be highlighted / acknowledged in their media release as well as in bold letters in the opening paragraphs of their Annual Report.

11. In addition, the investigator/host institute must also acknowledge the support provided to them in all publications, patents and any other output emanating out of the project /programme funded by Science & Engineering Research Board, a statutory body of the Department of Sciences & Technology (DST), Govt. of India.

12. The institute will maintain separate audited accounts for the project. If it is found expedient to keep a part or whole of the grant in a bank account earning interest, the interest earned should be reported to the SERB, New Delhi. The interest thus earned will be treated as a credit to the institute to be adjusted towards further installment of the grant.
