Subject: Upgradation of Junior Research Fellow JRF (NET) to Senior Research Fellow, SRF (NET)

Sir/Madam,

On the basis of satisfactory research progress of MS. RANJISHA K R as assessed and recommended by the three member assessment committee on completion of two years as JRF, the Head – Human Resource Development Group (CSIR) has been pleased to upgrade fellowship from JRF (NET) to SRF (NET) and enhance stipend from Rs 31000/- p.m. to Rs 35000/- p.m. with effect from 01/09/2019 to 31/08/2020.

The Senior Research Fellowship is subject to the existing terms & conditions governing CSIR fellowship which inter-alia provides that the total tenure of JRF and SRF (from all sources) combined is limited to five years.
