5. Grant-in-aid bill for releasing the first instalment of fellowship
6. Self-attested copy of Ph.D. Degree, SC/ST/PwD Certificate (*if applicable and if already not submitted*)

*(The formats are being sent along with the email and also available on Result Page on ICSSR website.)*

After receipt and acceptance of these documents by the ICSSR, a formal Sanction Order for the award of the Post-Doctoral Fellowship will be issued and subsequently the Fellowship shall be transferred through RTGS to the concerned Registrar/Director/Principal of the University/Institute/College along with a copy of the same to you. In case, the awardee does not join within 15 days from the date the issue of the Award Letter, the Application shall be treated as withdrawn. In case of any difficulty in joining, the awardee is required to inform the ICSSR and take its permission for any delay.
