 selected for the KSCSTE fellowship during the year 2015 in Physical Sciences. The first year
 fellowship was released vide reference (2).
- 2. The Second year fellowship period is 28.03.2018 27.03.2019. An amount of Rs.2,84,000/-(Rs.2,40,000/- towards the fellowship grant @ Rs.20,000/- per month + Rs.24,000/- towards HRA + Rs.20,000/- towards annual contingency) being the grant for the second year period.
- 3. As per ref. (3) the Council enhanced KSCSTE Research fellowship to Rs.22,000/- per month for the first two years and Rs.25,000/- per month for the third year along with HRA and an annual contingency of Rs.20,000/- with effect from 01.04.2018.
- 4. The fellow is eligible for the enhanced fellowship @ Rs.22,000/- per month from 01.04.2018 to 27.03.2019. The enhanced fellowship for second year grant is as detailed below
