Sanction of **Science and Engineering Research Board (SERB)** is hereby accorded to the above mentioned fellowship at a total cost of **Rs. 19,20,000/- (Rs. Nineteen Lakh Twenty Thousand Only)** for a duration of 24 months.

The date of start of the fellowship will be **02 June, 2017**

The items of expenditure for which the total allocation of **Rs. 19,20,000/-** has been approved are given below:

Sanction of the **SERB** is also accorded to the payment of **Rs. 9,60,000/- (Rupees Nine Lakh Sixty Thousand only)** under 'Grants-in-aid General' to **Central University Of Kerala, BKM Towers, Nayanmar Moola Vidyanagar P.O. Kasaragod** being the first installment of the grant for the year 2017-2018 for implementation of the said research project.

4. The Sanction has been issued to with the approval of the competent authority vide Diary No. **SERB/F/5288/2017-2018** dated **23 August, 2017**


