4. Any claim of fellowship as retrospective payment, will not be considered by this ministry.
5. If there is more than 4 months gap between date of assessment and date of upload in the "online portal", the date of uploading will be considered as SRF activation date.
6. In case the fellow has been assessed by committee in one year it is mandatory to include the published paper while uploading the assessment report. Otherwise the date of completion of two years will be considered as SRF activation date.
