Sl. No.	Budget Head	Amount
1.	Fellowship	Rs. 55,000/- per month (consolidated) (Rs. 35,000/- per month (consolidated) for applicants who have submitted the thesis & awaiting the award of the Ph.D degree)
2.	Research Grant	Rs. 2,00,000/- per annum
3.	Overheads	Rs. 1,00,000/- per annum

The fellow is requested to inform the tentative date of joining the fellowship in the host institute and submit relevant documents such as RTGS details, Scientific Social Responsibility (SSR) details, ethical / biosafety / stem cell / wildlife clearances and other relevant documents as applicable to the project within three months from the date of receipt of the approval letter.

The fellows shall be allowed to join in the host institute only after the issue of "Sanction Order" which is subject to the acceptance of the above documents by the competent authority in SERB and the fund availability aspects.

The fellow is required to join within a month of issue of sanction order and submit the joining report, pending which the approval shall stand withdrawn. In exceptional cases, the joining period can be extended by another one-month

subject to the approval of competent authority in SERB.

The funds are expected to be released to host institution within three weeks of issue of sanction order. The Fellowship will be effective from the date of issue of sanction order or date of joining in the host institution whichever is later.
