Subject: Upgradation of Junior Research Fellow JRF (NET) to Senior Research Fellow, SRF (NET)

Sir/Madam,

On the basis of satisfactory research progress of MS. PADMAPRIYA V P as assessed and recommended by the three member assessment committee on completion of two years as JRF, the Head – Human Resource Development Group (CSIR) has been pleased to upgrade fellowship from JRF (NET) to SRF (NET) and enhance stipend from Rs 31000/- p.m. to Rs 35000/- p.m. with effect from 01/03/2020 to 28/02/2021.

The Senior Research Fellowship is subject to the existing terms & conditions governing CSIR fellowship which inter-alias provides that the total tenure of JRF and SRF (from all sources) combined is limited to five years.

Head, HRDG, CSIR has further been pleased to sanction the following additional grant towards the stipend and contingency for the period commencing from 01/03/2020 to 28/02/2021

Stipend: Rs 4,20,000/-  
Contingency: Rs 20,000/-

No separate renewal sanction will be issued next year. The expenditure will be debited to the budget head grant-in-aid Fellowships P -81 101 for the current financial year.
