In continuation to SERB's sanction order of even number dated 21.12.2018 approval of the Science and Engineering Research Board (SERB) is hereby accorded for the faculty visit of Dr. Jasmine M Shah, Central University of Kerala, Tejaswini Hills, Periyar Post, Kasaragod, Kerala- 671316 at a sum of **Rs.2,23,010/- (Rupees two lakh twenty three thousand ten only)** to undertake 19 days research visit at Purdue University, West Lafayette, Indiana, USA in collaboration with Prof. Stanton B Gelvin from 18.10.2019 to 05.11.2019.

2. Sanction of the **Science & Engineering Research Board (SERB)** is hereby accorded for the payment of a sum of **Rs.2,08,398/- (Rupees two lakh eight thousand three hundred ninety eight only)** to Dr. Jasmine M Shah. The amount Rs.2,08,398/-, includes Travel fare of Rs.76,891/- and 90% of (Subsistence Allowance + Accommodation Charges+ Contingencies and related travel cost) i.e Rs.1,31,507/-.

3. Sanction of the grant is subject to the availability of funds and terms and conditions as specified by SERB from time to time and Memorandum of Understanding between Purdue University, USA and SERB, India.

4. The sanction has been issued with the approval of the competent authority in SERB vide Dy. No. SERB/F/5668/2019-20 dated 21.10.2019.

5. The amount of **Rs. 2,08,398/- (Rupees two lakh eight thousand three hundred ninety eight only)** will be drawn by the Under Secretary of the Board and will be disbursed to The Registrar, Central University of Kerala, Tejaswini Hills, Periyar Post, Kasaragod, Kerala- 671 316 by means of RTGS transaction as per Institute account details given below:

9. The Indian Institute will maintain separate audited accounts for the fellowship. If it is found expedient to keep a part or whole of the grant in a bank account earning interest, the interest earned should be reported to SERB.
10. As per rule 211 of GFR the accounts of Grantee Institution shall be open to inspection by the sanctioning authority / audit whenever the institute is called upon to do so.
11. The Institute will furnish to the SERB, Utilization Certificate and Statement of Expenditure pertaining to the grant as per SERB format.
12. After completion of the research visit unspent balance if any should be returned as Demand Draft drawn in favor of "Fund for Science and Engineering Research" payable at New Delhi.
