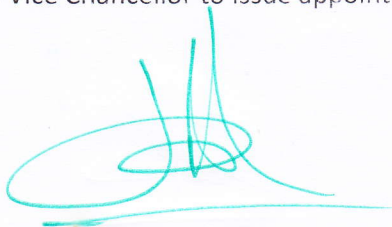

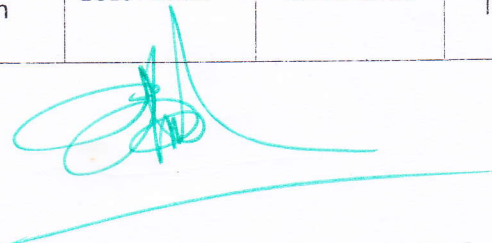

EC:02:15:25 Grant of Study Leave to Dr. P.A. Sinu, Asst. Professor, Dept, of Animal Science.

The Executive Council resolved to grant Study Leave to Dr. P.A. Sinu, Asst. Professor, Department of Animal Science from 08-07-2016 to 12-07-2017 as he has been selected for Raman Fellowship for Post-Doctoral Research in USA for the year 2015-16 awarded by UGC. He has to execute a bond with the University as required by Gol rules.

The Executive Council noted the letter dated 4-2-2016 from the Secretary, UGC regarding UGC Regulations on curbing the menace of Ragging in Higher Educational Institutions, 2009 and resolved to implement the Regulations in toto.

EC:02:15:27 Establishment of Women's Studies Centre under the scheme Development of Women's Studies in Indian Universities and Colleges.

The EC noted the letter dated 11th March 2016 from the Secretary, UGC and resolved to start Women's Studies Centre in the University under the scheme Development of Women's Studies in Indian Universities and Colleges. Further, the EC entrusted the Vice Chancellor to follow up with the UGC for faculty positions and supporting staff for the Centre.

Items brought from Finance Committee

EC:02:15:28 To consider the proposal for refund of the University hostel rent collected from the students belonging to Scheduled Caste/Tribe category in respect of earlier period.

The EC discussed the matter in detail and approved to refund the University Hostel Fee collected from the students belonging to Scheduled Caste/Tribes in respect of earlier periods also (with effect from 2009 admission onwards).

It was also resolved to release the refunds on getting requests received from the individual students thereto.

EC:02:15:29 **Proposal for reduction of rate of University hostel rent charged from the Students.**

The EC examined the matter in much depth and recommended to reduce the hostel rent from Rs.3,000/- to Rs.2,000/- per student per semester as against the Finance Committee recommendation of collecting hostel rent from Rs.3,000/- to Rs.2,500/- for per student per semester. The EC resolved so, by considering the minimum hostel rent being levied by other Central Universities.

Regarding the question of enhancement of rent after three years, as recommended by the FC, the EC disagreed and decided to review the question of enhancement later.

Since there is a difference in the resolution of the EC on the recommendation of the FC, the Vice-Chancellor suggested that the hostel rent issue be taken up with the MHRD and that a final decision will be taken, on receiving concurrence from MHRD.

Also, the EC authorized the Vice Chancellor to take up the matter immediately with MHRD.

EC:02:15:30 **Proposal to consider exemption from payment of Hostel fee in respect of girl students and Differently Abled Students.**

The EC agreed to the resolution of the FC to exempt the Differently Abled Students from payment of Hostel fee.

The EC also resolved to address the Ministry of Social Justice and Empowerment, Government of India for getting financial assistance sanctioned for Differently Abled Students.

Regarding exemption of girl students from payment of hostel fee, the EC endorsed the resolution of the FC, that the matter can be considered when enough funds are generated internally by the University from sources like Distance Education, Online Education, sponsored Endowments, Community Colleges etc.

EC:02:15:31 **Proposal to consider reduction of Bus fee charged from the University Students to and from University Campus/Hostel.**

The EC examined the matter in detail and resolved to reduce the bus fee charged from the University Students by 50% levied from UG and PG students and by 25% levied from PhD Scholars, endorsing the resolution of the FC as such, with effect from the next semester starting from July 2016.

The EC examined the matter in detail and endorsed the resolution of the FC that CUK shall request the UGC to review its position to discontinue the award of Merit cum Means Scholarship and to award the Merit cum Means Scholarship to a reduced number of students, at least.

The EC expressed its deep concern and anguish over the termination of Merit cum Means Scholarship by the UGC to the students who hail from much socio-economically deprived background.

The FC suggested that the award of Merit cum Means Scholarship can be considered once the financial resources are adequately been generated by CUK through Distance Education, Online Education, sponsored Endowments, Community Colleges etc.

The EC while agreeing with the resolution of the FC, authorized the Vice Chancellor to take up the matter with MHRD for getting financial assistance for the possibility of continuing the scheme.

(i) **To consider for Administrative Approval and Expenditure sanction for the development works of Hostel for Boys and Hostel for Girls, Periya Campus.**

The EC discussed the matter in detail and accorded Administrative Approval and Expenditure Sanction for an amount of Rs.2,31,73,000/- for the development works of Hostel for Boys and Hostel for Girls, Periya Campus, as furnished by the CPWD and as recommended by the Finance Committee.

The representative from MHRD stressed that in taking up any work, provisions of GFR, CVC guidelines, GoI and UGC guidelines should be strictly followed.

(ii) **To consider for Administrative Approval and Expenditure Sanction for development works of the 8 Academic Buildings - Phase I - Rs.41,78,63,421/-**

The EC discussed the matter in length and accorded Administrative Approval and Expenditure Sanction for an amount of Rs. 41,78,63,421/- for the development works for the 8 Academic Buildings – Phase I which is in progress. The work will be taken up for execution only according to the availability of funds for payment.

The representative from MHRD stressed that in taking up any work, provisions of GFR, CVC guidelines, GoI and UGC guidelines should be strictly followed.

(iii) **To consider for Administrative Approval and Expenditure Sanction for the construction of compound wall, protection wall, and RR masonry retaining wall on the south west corner of Girls Hostel Building. Rs.35,25,100/-**

The EC noted that a-compound wall with more height and depth at this stretch (nearly 72 meter long) was necessitated because of the encroachment by the neighbour. And also in view of the exigencies expressed for opening the Girl's Hostel the FC agreed to the proposal for the work subject to approval of the Court appointed Commission. The FC was apprised that the land of the encroacher (approximately 1 acre) had already been attached in favour of CUK by a Court order.

The EC agreed the recommendations of the Finance Committee and resolved to accord Administrative Approval and Expenditure Sanction for the construction of compound wall, protection wall, and RR masonry retaining wall on the south west corner of Girls Hostel Building for an amount of Rs.35,25,100/-

The representative from MHRD stressed that in taking up any work, provisions of GFR, CVC guidelines, GoI and UGC guidelines should be strictly followed.

(iv) **To consider for Administrative Approval and Expenditure Sanction for construction of 2 Nos of open wells and 1 No. of Bore well at Periya Campus Rs. 54,02,700/-**

The EC agreed the recommendations of the Finance Committee and resolved to accord Administrative Approval and Expenditure Sanction for construction of 2 Nos of open wells and 1 No. of Bore well at Periya Campus, at an estimated cost of Rs. 54,02,700/-

The representative from MHRD stressed that in taking up any work, provisions of GFR, CVC guidelines, GoI and UGC guidelines should be strictly followed.

(v) **To consider for according Administrative Approval and Expenditure Sanction for Rs.5,50,000/- for extension of LT supply to the 16 Nos of houses for Malathumpara colony.**

The EC agreed the recommendations of the Finance Committee and resolved to accord Administrative Approval and Expenditure Sanction for Rs.5,50,000/- for extension of LT supply to the 16 Nos of Houses and Community Hall while shifting the Malathumpara colony from the midst of CUK Campus to the area earmarked for the purpose.

The representative from MHRD stressed that in taking up any work, provisions of GFR, CVC guidelines, GoI and UGC guidelines should be strictly followed.



(vi) **To consider approval for the leasing out of 2 Acres of land to KSEB for construction of 110 KV sub-station and also to meet the Power requirements of the whole Periya Campus**

The EC discussed the matter at length and accorded approval for the leasing out of 2 Acres of land to KSEB for construction of 110 KV sub-station and also to meet the Power requirements of the whole Periya Campus.

The EC also resolved the lease of land under Gol possession only after getting approval from the MHRD.

Further, the EC authorized the Vice Chancellor to write to the MHRD, for getting approval for the lease of 2 acres of land to KSEB.

(vii) **To consider for approval for the compensation package for Malathumpara colony shifting - University's Periya campus.**

The Vice Chancellor explained that an understanding for settling the compensation package was arrived at through a series of meetings and discussions held between the University and the colony people, with the involvement of the District Collector and the Revenue functionaries. According to the package approved, the University has to pay an amount of Rs.30,86,115/- including the 50% hike and shifting charges to the house owners. The expenditure towards this will be met from the funds already provided by the State Government to the University.

The EC resolved to approve the compensation package arrived at by the University for the shifting of Malathumpara Colony as detailed by the Vice Chancellor.

(viii) **To consider for Administrative Approval and Expenditure Sanction for additional works for the Four Wheeler shed cum Multipurpose hall - Rs. 28,14,000/-**

The Vice Chancellor apprised the EC that additional work of four wheeler shed cum multipurpose hall was necessitated due to additional work done for Central Library Hall and the requirement of a spacious Library Hall before the anticipated visit by the NAAC and that the partition and allied works amounting to Rs.23,40,000/- is nearing completion.

The Monitoring Committee held on 21-01-2016 had recommended for providing additional space for Drivers, Security and Common Room etc. in the four wheeler cum Multipurpose hall with an additional cost of Rs.4,74,000/-.

Hence, a total of Rs.28,14,000/- is required to be incorporated as additional works associated with Multipurpose hall and the work is in progress.

The EC resolved to approve the recommendations of the Finance Committee and accorded Administrative Approval and Expenditure Sanction for the additional works for the four wheeler shed cum Multipurpose hall, at an estimated cost of Rs.28,14,000/-.



The representative from MHRD stressed that in taking up any work, provisions of GFR, CVC guidelines, GoI and UGC guidelines should be strictly followed.

The meeting ended with vote of thanks to and from the Chair.
