He then briefed the Members about details pertaining to the Convocation ceremony.

The Vice-Chancellor informed the members that various committees had been formed for the conduct of the Convocation ceremony and sought the whole-hearted cooperation, support and participation of one and all for the successful conduct of the Convocation.

The second Convocation of the Central University of Kerala scheduled to be held on 8th June, 2017 between 12.00 Noon to 1.00 p.m. at the Chandragiri Open Air Auditorium, Periye Campus Shri. Prakash Javadekar, Hon'ble Minister of Human Resource Development, Govt. of India, has consented to grace the occasion as Chief Guest.

The Vice Chancellor solicited the active involvement and co-operation of all the members of the Executive Council for the successful conduct of the Convocation.

The Executive Council approved the Second Convocation of the University and resolved to authorize the Vice-Chancellor to take all necessary steps including incurring of all the expenditure for various arrangements relating to the conduct of the Convocation.

	disciplinary proceeding against Non-teaching employees of the University

The Vice Chancellor is authorized to initiate all kind of disciplinary proceedings against non-teaching employees of the University in addition to the powers already vested with Registrar under clause 6(5) a of the 1st Statutes.

While discussing the matter, the Council noted the comments received from the MHRD vide letter No. F.No. 46-3/2017-CU.III, dated 07^{the} June, 2017 on the agenda item " to delegate and authorize the Vice Chancellor to initiate all kind of disciplinary proceeding against Non-teaching employees of the University" as follows:

"As per CU Act 2009 (Statute 6 (5) (b), Vice Chancellor is the Appellate Authority against the order of Registrar who is the Disciplinary Authority. Hence such delegation of powers may be avoided". Regarding this the Vice Chancellor opined that such a resolution is required to ratify certain actions taken by the University. Taken into consideration of the opinion of Vice Chancellor the Executive Council unanimously resolved as follows:

"The Executive Council hereby resolves to delegate and authorize the Vice Chancellor to initiate all kind of disciplinary proceedings against Non-teaching employees of the University in addition to the powers already vested with Registrar under Clause 6 (5) a of the 1st Statutes.

The Executive Council hereby further resolves to delegate and authorize the Vice Chancellor to initiate all kind of disciplinary proceedings against teachers and other academic staff of the University in addition to the powers vested under the Clause 25 of the 1st Statutes.

The Executive Council hereby ratifies all the actions taken by the Vice Chancellor in relation to the disciplinary proceedings against teaching and non-teaching employees of this University".
