

The Executive Council has noted the fact that students are not having any proper facility for Sports and Game activities in this Campus. Focussed attention and guidance are not possible under the present circumstances for the development of Sports and games activities.

The Executive Council also considered the NAAC visit to CUK in the immediate future, where Sports and games are important elements for NAAC evaluation. Therefore EC agreed for the creation of a supernumerary post of Co-ordinator in Physical Education under Section 19(1) of Statute of Central University of Kerala for a specific period of not more than one year.

The Executive Council authorized the Vice Chancellor to appoint a suitable person for this purpose. The Executive Council resolved to give the invited person a consolidated amount of Rs.50,000/- per month for the current academic year on contract basis (10 months). The clearance of Finance Committee is to be obtained in this regard.

The Executive Council considered the fact that since it is not possible to convene the Finance Committee before its expiry on 30.05.2016, it will be better to circulate the EC resolution to all members of Finance Committee for their concurrence.
